

# Annual Meeting of the Holders of Common Shares April 20, 2018

#### REPORT OF VOTING RESULTS

The following matters were voted upon at the Annual Meeting of the Holders of Common Shares of National Bank of Canada (the "Bank") held on April 20, 2018. The vote on each matter was conducted by secret ballot.

#### 1. Election of Directors
